
【Second Quarter 2017 Results】

BizLink Holding inc. (TWSE: 3665) today reported results for the second quarter of 2017. Audited consolidated net sales totaled NT\$ 3,659,873 thousand* (US\$ 120,953 thousand), an increase of 60.54% (calculations made in NT\$) from the same period in 2016. The EPS for the quarter was NT\$ 2.81 (US\$ 0.0928).

Gross Profit Margin for the quarter was 26%. Net Operating Income was 10.6%.

2017Q2 Highlights

- Information Technology product lines maintained their growth momentum in Q2
- Motor Vehicle: Both EV and ATV harnesses pull-in volume showed continued growth
- Industrial harnesses pull-in strengthened
- Revenue from Electrical Appliances Business Unit contributed to group financials starting beginning of May**

Outlook for the Subsequent Two Quarters

- Information Technology: Continued launch of next generation docking stations with mass-production expected during latter half of Q3
- Motor Vehicle: ATV harnesses will approach peak demand while harnesses for new EV models will contribute to a steeper growth trajectory
- Industrial harnesses are expected to ship in greater volumes due to strong demand from the semiconductor equipment market
