### December 2023 Monthly Sales Report

BizLink Holding Inc. (TWSE code: 3665) announced that consolidated net sales for December 2023 totaled US\$ 111,450 thousand, a decrease of 13.96% MoM\* and a decrease of 14.39% YoY\*\*. The consolidated net sales for 2023 reached US\$ 1,633,877 thousand, a decrease of 9.25% YoY\*\*\*.

#### Monthly Update (MoM):

Overall shipments fell on fewer workdays as many took their year-end Christmas and New Years break.

#### Segment Commentary (MoM):

- Industrial: overall shipments fell albeit those to capital equipment and medical customers were stable.
- IT DataComm: shipments to peripherals customers moved lower while those to HPC customers rose.
- Automotive: shipments to non-EV customers dropped while those to EV customers increased.
- Electrical Appliance: overall shipments were lower due to holiday vacations.

\* The consolidated net sales for November 2023 totaled US\$ 129,530 thousand.

\*\* The consolidated net sales for December 2022 totaled US\$ 130,190 thousand.

\*\*\* The consolidated net sales for 2022 totaled US\$ 1,800,482 thousand.
